เรื่อง หลักเกณฑ์และพิธีการการยกเว้นอากรและ  
ลดอัตราอากรศุลกากรสำหรับเขตการค้าเสรีอาเซียน - จีน (ฉบับที่ ๒)

เพื่อปฏิบัติตามข้อผูกพันตามกรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจระหว่างสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐประชาชนจีน (Framework Agreement on Comprehensive Economic Co-operation between the Association of Southeast Asian Nations and the People's Republic of China) และความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจระหว่างสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐประชาชนจีน (Agreement on Trade in Goods of the Framework Agreement on Comprehensive Economic Co-operation between the Association of Southeast Asian Nations and the People's Republic of China) และเพื่อให้เป็นไปตามประกาศกระทรวงการคลัง เรื่อง การยกเว้นอากรและลดอัตราอากรศุลกากรสำหรับเขตการค้าเสรีอาเซียน - จีน ลงวันที่ ๒๘ ธันวาคม พ.ศ. ๒๕๖๔ ซึ่งให้ยกเว้นอากรและลดอัตราอากรสำหรับเขตการค้าเสรีอาเซียน - จีน โดยให้ปฏิบัติพิธีการศุลกากรตามทื่อธิบดีกรมศุลกากรกำหนด

อาศัยอำนาจตามความในมาตรา ๗ มาตรา ๒๕ มาตรา ๕๑ และมาตรา ๖๓ แห่งพระราชบัญญัติศุลกากร พ.ศ. ๒๕๖๐ อธิบดีกรมศุลกากรจึงออกประกาศไว้ ดังต่อไปนี้

ข้อ ๑ ให้ยกเลิกความใน (๑.๑) ของข้อ ๕ แห่งประกาศกรมศุลกากร ที่ ๒๑๘/๒๕๖๔ เรื่อง หลักเกณฑ์และพิธีการการยกเว้นอากรและลดอัตราอากรศุลกากรสำหรับเขตการค้าเสรีอาเซียน - จีน ลงวันที่ ๒๙ ธันวาคม พ.ศ. ๒๕๖๔ และให้ใช้ความต่อไปนี้แทน

“(๑.๑) รูปแบบหนังสือรับรองถิ่นกำเนิดสินค้า (Form E) จะต้องเป็นไปตามเอกสารแนบ ๔-๑ เอกสารแนบ ๔-๒ เอกสารแนบ ๔-๓ และเอกสารแนบ ๔-๔ แนบท้ายประกาศนี้ ทั้งนี้ หนังสือรับรองถิ่นกำเนิดสินค้า (Form E) จะต้องออกโดยหน่วยงานผู้มีอำนาจในการออกหนังสือรับรองถิ่นกำเนิดสินค้า (Form E) ของประเทศภาคีสถผู้ส่งของออก และต้องมีตราประทับพร้อมทั้งลงลายมือชื่อด้วยตนเองโดยผู้มีอำนาจของหน่วยงานดังกล่าว ซึ่งได้มีการแจ้งบัญชีรายชื่อและที่อยู่ และบัญชีของตัวอย่างลายมือชื่อและตัวอย่างตราประทับที่เป็นทางการหรือตราประทับสำหรับการแก้ไขที่ใช้ในสำนักงานของหน่วยงานผู้มีอำนาจในการออกหนังสือรับรองถิ่นกำเนิดสินค้าไว้ต่อกรมศุลกากรแล้ว

หนังสือรับรองถิ่นกำเนิดสินค้า (Form E) ที่ออกโดยสาธารณรัฐประชาชนจีน ตามเอกสารแนบ ๔-๒ และเอกสารแนบ ๔-๓ สามารถใช้ตราประทับและลายมือชื่อในรูปแบบอิเล็กทรอนิกส์ได้ โดยต้องจัดพิมพ์เป็นสีโดยหน่วยงานผู้มีอำนาจในการออกหนังสือรับรองถิ่นกำเนิดสินค้าหรือผู้ส่งของออกของสาธารณรัฐประชาชนจีนเท่านั้น และต้องมี Overleaf Notes อยู่ด้านหลังของกระดาษแผ่นเดียวกัน ทั้งนี้ ผู้ส่งของออกจะต้องส่งต้นฉบับ (Original) ของหนังสือรับรองถิ่นกำเนิดสินค้า (Form E) ดังกล่าวไปยังผู้นำของเข้า เพื่อแสดงต่อสำนักงานศุลกากรหรือด่านศุลกากรที่นำของเข้า

หนังสือรับรองถิ่นกำเนิดสินค้า (Form E) ที่ออกโดยประเทศมาเลเซีย ตามเอกสารแนบ ๔-๔ สามารถใช้ตราประทับและลายมือชื่อในรูปแบบอิเล็กทรอนิกส์ได้ โดยต้องจัดพิมพ์เป็นสีหรือขาว-ดำ โดยหน่วยงานผู้มีอำนาจในการออกหนังสือรับรองถิ่นกำเนิดสินค้าหรือผู้ส่งของออกของประเทศมาเลเซียเท่านั้น และต้องมี Overleaf Notes อยู่ด้านหลังของกระดาษแผ่นเดียวกัน ทั้งนี้ ผู้ส่งของออกจะต้องส่งต้นฉบับ (Original) ของหนังสือรับรองถิ่นกำเนิดสินค้า (Form E) ดังกล่าวไปยังผู้นำของเข้า เพื่อแสดงต่อสำนักงานศุลกากรหรือด่านศุลกากรที่นำของเข้า

ในกรณีที่ไม่ปรากฏลายมือชื่อหรือตราประทับหรือปรากฏลายมือชื่อ และ/หรือตราประทับของเจ้าหน้าที่หรือหน่วยงานที่ไม่ได้อยู่ในบัญชีที่อ้างถึงในวรรคหนึ่งจะไม่ได้รับการยอมรับจากกรมศุลกากร”

For China, a Chinese manufacturer can apply for a Certificate of Origin (Form E) in the case where the manufacturer needs to authorise other agencies to export on its behalf. In this case, the manufacturer can make the declaration indicated in Box 11 and shall state the name and address of the exporter in Box 7.
8. FOR OFFICIAL USE: The Customs Authority of the importing Party must indicate (√) in the relevant boxes in column 4 whether or not preferential treatment is accorded.
9. MOVEMENT CERTIFICATE: In cases of Movement Certificate, in accordance with Rule 12 of Attachment A of the Rules of Origin of the ACFTA Upgrading Protocol (Operational Certification Procedures): (i) “Movement Certificate” in Box 13 should be ticked (√); (ii) the indicated value in Box 9 shall be the invoice value of the products exported from the intermediate Party. The indicated value in Box 9 is only required when the RVC criterion is applied; (iii) The name of the original Issuing Authorities of the Party, date of the issuance and the reference number of the original Certificate of Origin (Form E) to be indicated in Box 7.
10. THIRD PARTY INVOICING: In cases where invoices are issued by a third country, “the Third Party Invoicing” in Box 13 shall be ticked (√). The invoice number shall be indicated in Box 10. Information such as name and country of the company issuing the invoice shall be indicated in Box 7.
11. EXHIBITIONS: In cases where products are sent from the exporting Party for exhibition in another Party and sold during or after the exhibition for importation into a Party, in accordance with Rule 22 of Attachment A of the Rules of Origin for the ACFTA, the “Exhibitions” in Box 13 should be ticked (√) and the name and address of the exhibition indicated in Box 2.
12. ISSUED RETROACTIVELY: In exceptional cases, due to involuntary errors or omissions or other valid causes, the Certificate of Origin (Form E) may be issued retroactively in accordance with Rule 11 of Attachment A of the Rules of Origin for the ACFTA. The “Issued Retroactively” in Box 13 shall be ticked (√) electronically or typewritten together with other information in the Certificate of Origin (Form E). In cases where the “Issued Retroactively” in Box 13 cannot be ticked electronically or typewritten, the Certificate of Origin (Form E) shall be stamped with the words “ISSUED RETROACTIVELY”

- (ii) must comply with all relevant provisions of Annex 1 (Rules of Origin) of the Protocol to Amend the Framework Agreement on Comprehensive Economic Co-operation and Certain Agreements thereunder between the Association of Southeast Asian Nations (ASEAN) and the People’s Republic of China (ACFTA Upgrading Protocol).

3. ORIGIN CRITERIA: For each good described in Box 7 of this form, the origin criteria met should be indicated in Box 8, in the manner shown in the following table:
